The Court, having reviewed the *Omnibus Stipulation Continuing Hearing On Certain Objections to Notice and Supplemental Notice of Contracts Designated For Assumption and Assignment* (the “Stipulation”), filed as Docket No. 2169, entered between the above-captioned debtors and debtors in possession (the “Debtors”), on the one hand, and NFS Leasing, Inc., Roche Diagnostics Corporation, NTT DATA Services Holding Corporation, AppleCare Medical Group, Inc., AppleCare Medical Group, St. Francis Inc., and AppleCare Medical Management LLC, UnitedHealthcare Insurance Company, GE HFS, LLC, Kaiser Foundation Hospitals, Experian Health Inc., f/k/a Passport Health Communications, Inc., Smith & Nephew, Inc., Conifer Health Solutions, LLC, Medtronic USA, Inc., QuadraMed Affinity Corporation and Picis Clinical Solutions Inc., Angeles IPA Medical Group, Aetna Life Insurance Company, Parallon Revenue Cycle Services, Inc. f/k/a The Outsource Group, Inc., St. Vincent IPA, SCAN Health Plan, DaVita Inc., and Premier, Inc. and its subsidiaries (together, the “Counterparties”), and good cause appearing,

HEREBY ORDERS AS FOLLOWS:

1. The Stipulation is approved.
2. The Hearing Date (as defined in the Stipulation) to consider the Cure Objections (as defined in the Stipulation) shall be continued from April 17, 2019, at 10:00 a.m. to June 5, 2019, at 10:00 a.m. (Pacific Time).
3. The deadline for the Debtors to reply to the Cure Objections is May 29, 2019, at 4:00 (PST).
