This stipulation is entered between Verity Health System of California, Inc. and the abovereferenced affiliated debtors, the debtors and debtors in possession in the above-captioned chapter 11 bankruptcy case (collectively, the "Debtors"), on the one hand, and Abbott Laboratories Inc. and Alere Informatics, Inc. (collectively, "Abbott"), on the other, in the above-captioned jointly administered cases with respect to the following:

- 1.
