The Court, having reviewed the *Stipulation Continuing Hearing Re Objection of Cigna Entities to Notice to Counterparties to Executory Contracts and Unexpired Leases of the Debtors That May Be Assumed and Assigned* (the “Stipulation”), filed as Docket No. 2190, entered between the above-captioned debtors and debtors in possession (the “Debtors”) and Cigna Healthcare of California, Inc., Cigna Health and Life Insurance Company, and Life Insurance Company of North America (collectively, “Cigna”), and good cause appearing,

HEREBY ORDERS AS FOLLOWS:

1. The Stipulation is approved.
2. The Hearing Date (as defined in the Stipulation) to consider the Cigna Objection shall be continued from April 17, 2019, at 10:00 a.m., to June 5, 2019, at 10:00 a.m. (Pacific Time). Any order entered approving the sale will not approve the assumption and assignment of the Cigna Contracts. All arguments asserted in the Cigna Objection are preserved.
3. The deadline for the Debtors to reply to the Cigna Objection (as defined in the Stipulation) is May 29, 2019, at 4:00 (PST).
