The Court, having reviewed the *Stipulation Continuing Hearing Re Objection of NantHealth, Inc. to Proposed Assumption and Assignment of Executory Contracts and Unexpired Leases* (the “Stipulation”), filed as Docket No. [2208], entered between the above-captioned debtors and debtors in possession (the “Debtors”) and NantHealth, Inc. (“NantHealth”), and good cause appearing,

HEREBY ORDERS AS FOLLOWS:

1. The Stipulation is approved.
2. The Hearing Date (as defined in the Stipulation) to consider the NantHealth Objection (as defined in the Stipulation) shall be continued from April 17, 2019, at 10:00 a.m., to June 5, 2019, at 10:00 a.m. (Pacific Time). Any order entered approving the sale will not approve the assumption and assignment of the NantHealth agreements. All arguments asserted in the NantHealth Objection are preserved.
3. The deadline for the Debtors to reply to the NantHealth Objection is May 29, 2019, at 4:00 (PST).
