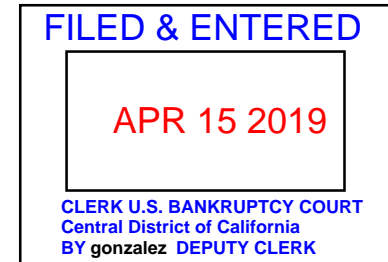

19 1] (the "Complaint"), or in the alternative, that this Court stay this adversary proceeding  
20 until the parties have completed arbitration of the claims asserted in the Complaint  
21 pursuant to the mandatory arbitration clauses in the contracts alleged in the Complaint,  
22 came for hearing before the Court on April 3, 2019.

23 The Court, having reviewed the Motion, the Complaint; *Notice of Motion for Entry*  
24 *of Order Dismissing Complaint or, in the Alternative, Motion for Entry of Order Staying*  
25 *Trial of Adversary Proceeding* [Doc. No. 14]; *Plaintiffs' Amended Opposition to Motion for*  
26 *Entry of Order Dismissing Complaint or, in the Alternative, Motion for Entry of Order*  
27 *Staying Trial of Adversary Proceeding* [Doc. No. 32]; *Reply Brief in Support of Motion for*  
28 *Entry of Order Dismissing Complaint or, in the Alternative, Motion for Entry of Order*  
*Staying Trial of Adversary Proceeding* [Doc. No. 36]; LA Care's *Motion for Entry of*  
*Protective Order, and Memorandum of Points and Authorities in Support Thereof* [Doc.

No. 20]; *Plaintiffs' Opposition to Motion for Entry of Protective Order* [Doc. No. 26]; LA Care's *Reply Brief in Support of Motion for Entry of Protective Order* [Doc. No. 35]; the parties' *Joint Status Report* [Doc. No. 18]; LA Care's *Memorandum of Points and Authorities Regarding Non-Core Designation* [Doc. No. 19]; and *Plaintiffs' Response to Defendant's Memorandum of Points and Authorities Regarding Non-Core Designation* [Doc. No. 22], and for the reasons set forth in the Court's tentative ruling (as amended by the Court after the April 3, 2019 hearing) [Doc. No. 39-1], which the Court adopts as its final ruling and which is incorporated herein by reference, and good cause having been shown,

**IT IS HEREBY ORDERED THAT:**

1. The Motion is GRANTED with respect to its alternative request for an order staying this adversary proceeding.

2. This adversary proceeding will be stayed pending the completion of arbitration of the claims for relief asserted in the Complaint.

3. Any determinations made by the arbitrator with respect to the Fourth and Eighth Claims for Relief (for purported violations of the automatic stay) and the Ninth Claim for Relief (seeking injunctive relief) shall be subject to the review and approval of this Court upon motion by any party after completion of the arbitration.


4. A Status Conference shall be held on June 19, 2019 at 10:00 a.m. No later than fourteen days prior to the hearing, the parties shall file a Status Report discussing the status of arbitration.
