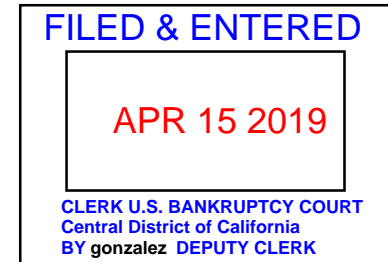

8 incorporated herein by reference, and good cause having been shown,


9 **IT IS HEREBY ORDERED THAT:**
