## <u>PUBLIC MEETING ON THE PROPOSED SALE OF VERITY HEALTH</u> <u>SYSTEM, ST. FRANCIS MEDICAL CENTER, ST. VINCENT MEDICAL</u> <u>CENTER, SETON MEDICAL CENTER, AND SETON COASTSIDE</u>

The Attorney General is reviewing the proposed sale of St. Francis Medical Center, a 314licensed bed general acute care hospital located in Lynwood, California, St. Vincent Medical Center, a 339-licensed bed general acute care hospital located in Los Angeles, California, Seton Medical Center, a 250-licensed bed general acute care hospital located in Daly City, California, and Seton Coastside, a 5-licensed bed general acute care hospital and 116-licensed bed skilled nursing facility, located in Moss Beach, California. The "Asset Purchase Agreement" is among Verity Health System of California, Inc., a California nonprofit public benefit corporation, Verity Holdings, LLC, a California limited liability company, St. Francis Medical Center, a California nonprofit public benefit corporation, St. Vincent Medical Center, a California nonprofit public benefit corporation, St. Vincent Dialysis Center, Inc., a California nonprofit public benefit corporation, and Seton Medical Center, a California nonprofit public benefit corporation, as Sellers, and Strategic Global Management, Inc., a California for-profit corporation as Purchaser. The proposed nonprofit hospital transaction is being reviewed under Corporations Code sections 5914 et seq. and being reviewed under Title 11, California Code of Regulations, Section 999.5, subdivision (h) as a request to amend the prior Conditions issued by the Attorney General on December 3, 2015.
