1 The Court has considered the *Stipulation between St. Francis Medical Center and Angeles*
2 *IPA Medical Group for Resolution of Cure Objection* (the “Stipulation”) [Docket No. 3046] filed on
3 September 12, 2019. The Stipulation is between St. Francis Medical Center, one of the debtors and
4 debtors in possession in the above-captioned chapter 11 cases, on the one hand, and Angeles IPA
5 Medical Group, on the other hand. It appears that the Stipulation is fair and reasonable.
