The Court, having reviewed the *Stipulation Regarding Pre-Petition Claims of Long Beach Memorial Medical Center* (the "<u>Stipulation</u>"), <sup>1</sup> filed as Docket No. 3053, entered between the above-captioned debtors and debtors in possession (the "<u>Debtors</u>") and Long Beach Memorial Medical Center ("LBMMC") and good cause appearing,

## **HEREBY ORDERS AS FOLLOWS:**

- 1. The Stipulation is approved in its entirety.
- 2. Proof of claim no. 5051 filed on March 29, 2019 in the total amount of \$3,807,136.29 by LBMMC (the "LBMMC Proof of Claim") shall be allowed as a general unsecured claim against St. Francis Medical Center in the amount of \$3,807,136.29 and shall be treated under the Debtors' Chapter 11 plan or otherwise.
  - 3. LBMMC has withdrawn its § 503(b)(9) Claim.
- 4. LBMMC reserves all rights to file any rejection damages claim in the future and the Debtors reserve all rights to object to any such claim.
- 5. LBMMC reserves all rights to file any motion or claim for allowance and/or payment of post-petition administrative expense in the future and the Debtors reserve all rights to object to any such motion or claim.
- 6. The Debtors reserve all preference and other causes of action which they or any successor to the Debtors (including, without limitation, any trust) may have against LBMMC and LBMMC reserves all rights to defend against any such cause of action on any grounds.
