Having reviewed the Debtors' Emergency Motion for the Entry of an Order: (I) Enforcing the Order Authorizing the Sale to Strategic Global Management, Inc.; (II) Finding that the Sale is Free and Clear of Conditions Materially Different Than Those Approved by the Court; (III) Finding That the Attorney General Abused His Discretion in Imposing Conditions on the Sale; and (IV) Granting Related Relief [Doc. No. 3188] (the "Motion"), the Court HEREBY FINDS AND ORDERS AS FOLLOWS:

- 1) A hearing on the Motion is set for **October 15, 2019, at 10:00 a.m.** In view of the significance of the relief sought in the Motion, the Debtors' request for a hearing on the Motion on 48 hours' notice is DENIED. The Debtors have not shown that a hearing on 48 hours' notice is necessary either to (a) preserve the ability of SGM¹ to timely close the SGM Sale or to (b) enable the Debtors to achieve the milestones set forth in the Cash Collateral Agreement. However, given the importance of the SGM Sale to these cases and the Debtors' continued operating losses, a hearing on fewer than 21 days' notice is warranted.
- 2) Opposition to the Motion shall be submitted by no later than **October 8, 2019**. Replies in support of the Motion shall be submitted by no later than **October 10, 2019**.
- 3) By no later than **October 1, 2019**, **at 12:30 p.m.**, the Debtors shall provide telephonic notice of the hearing to the California Attorney General, the Official Committee of Unsecured Creditors, the Debtors' prepetition secured creditors, SGM, the Office of the United States Trustee, and the United States Department of Health and Human Services.
- 4) By no later than **October 1, 2019**, the Debtors shall serve this Order and the Motion upon the California Attorney General, the Official Committee of Unsecured Creditors, the Debtors' prepetition secured creditors, SGM, the Office of the United States Trustee, and the United States Department of Health and Human Services. Service may be accomplished by any of the following methods: (a) personal service, (b) overnight mail, (c) facsimile, or (d) e-mail.
- 5) By no later than **October 3, 2019**, the Debtors shall file a declaration establishing that service was made in accordance with this Order.
