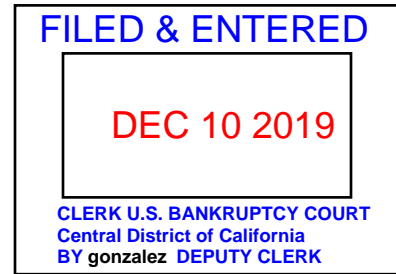

6 Bankruptcy Rule 9013-1(m); and good cause appearing therefor,


7 HEREBY ORDERS AS FOLLOWS:
