The Court, having read and considered the Stipulation Extending Litigation Deadlines and Continuing Pre-Trial Conference and Trial Week Dates (the “Stipulation”) submitted by Plaintiffs and Defendant¹ in the above-encaptioned adversary proceeding, and good cause appearing therefore, it is ORDERED, ADJUDGED and DECREED as follows:

1. The Stipulation is approved.
2. The Current Scheduling Order [Docket No. 47] in this case shall remain in full force and effect except as revised below:

¹ Capitalized terms used herein shall have the meanings ascribed to them in the Stipulation.

1 (a) The last day to complete discovery (except as to experts), including hearings
2 on discovery motions be extended from April 17, 2020 to June 20, 2020;

3 (b) The last day to disclose expert witness and expert witness reports is extended
4 from February 14, 2020 to June 25, 2020;

5 (c) The last day to disclose rebuttal expert witnesses and rebuttal expert witness
6 reports be extended from March 13, 2020 to July 24, 2020;

7 (d) The last day to complete discovery relating to expert witnesses, including
8 hearings on motions related to expert discovery, be extended from April 16, 2020 to August 25,
9 2020;


10 (e) The last day for dispositive motions to be heard be extended from March 26,
11 2020 to August 7, 2020;

12 (f) The Pre-Trial Conference presently set for May 12, 2020 at 11:00 a.m. be
13 continued to ~~September 15, 2020~~ ~~September 2, 2020~~ at 11:00 a.m.; and

14 (g) Trial, currently set for the week of May 25, 2020 be continued to the week of
