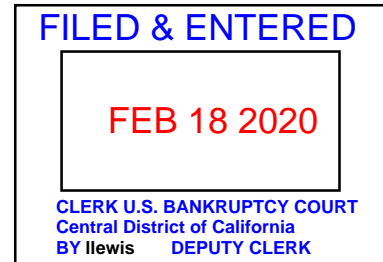


Based upon the foregoing, and having reviewed the Joint Status Report filed by the parties,
