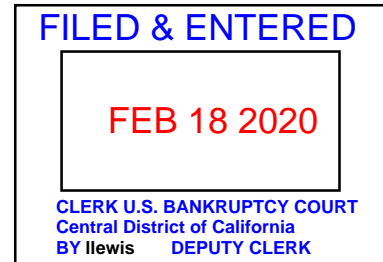

On January 7, 2020, the Court approved a stipulated adjournment of the hearing on *Defendant's Motion to Dismiss Amended Complaint* (the "Motion to Dismiss") [Doc. 
Based upon the foregoing, and having reviewed the Joint Status Report filed by the parties,
