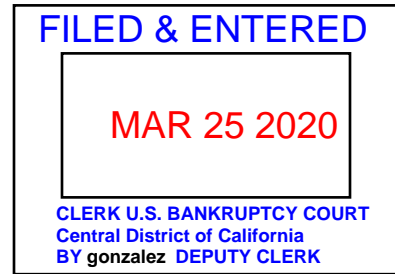

1 The Court, having reviewed the *Second Stipulation Continuing Objection Deadline*  
2 *Regarding Transfer of Medi-Cal Provider Agreement Related to Proposed Sale of St. Francis*  
3 *Medical Center* (the “Stipulation”),<sup>1</sup> filed as Docket No. 4317, entered between the above-  
4 captioned debtors and debtors in possession (the “Debtors”), on the one hand, and United States  
5 of America, on behalf of the California Department of Health Care Services (“DHCS”), on the  
6 other hand, and good cause appearing therefor,


7 HEREBY ORDERS AS FOLLOWS:

- 8 1. The Stipulation is approved.
- 9 2. The deadline for DHCS to file an Objection with respect to the transfer of the

- 11 3. The deadline to file replies to any Objection shall be May 6, 2020.
- 12 4. The Court shall hold a hearing on any Objection on May 13, 2020, at 10:00 a.m.  
13 (Pacific Time).
- 14 5. Nothing contained herein is a waiver of any rights, claims, interests, arguments or  
15 contentions of the parties hereto regarding the subject matter hereof, or the Sale, and all such  
16 rights, claims, interests, arguments and contentions are expressly reserved.
