4 on discovery motions is extended from June 20, 2020 to September 18, 2020;

5 3. The last day to disclose expert witness and expert witness reports is
6 extended from June 25, 2020 to September 23, 2020;

7 4. The last day to disclose rebuttal expert witnesses and rebuttal expert witness
8 reports is extended from July 24, 2020 to October 22, 2020;

9 5. The last day to complete discovery relating to expert witnesses, including
10 hearings on motions related to expert discovery, is extended from August 25, 2020 to
11 November 23, 2020;

12 6. The last day for dispositive motions to be heard is extended from August 7,
13 2020 to November 5, 2020;

14 7. The Pre-Trial Conference presently set for September 15, 2020 at 11:00
15 a.m. is continued to December 15, 2020 at 11:00 a.m.;

16 8. Trial, currently set for the week of September 28, 2020 is continued to the
17 week of January 11, 2021.

18 9. All other terms and deadlines set forth in the Current Scheduling Order
19 [Docket No. 40] are to remain in full force and effect;

20 10. This order is without prejudice to any party to seek further deadline, Pre-Trial
21 or Trial Week extensions for good cause shown.
