#### **STIPULATION**

Appellees Verity Health System of California, Inc., a California nonprofit public benefit corporation, St. Vincent Medical Center, a California nonprofit public benefit corporation, St. Vincent Dialysis Center, Inc., a California nonprofit public benefit corporation, and St. Francis Medical Center, a California nonprofit public benefit corporation, Seton Medical Center, a California nonprofit public benefit corporation, and Verity Holdings, LLC, a California limited liability company (collectively, "Verity"), Appellant Strategic Global Management, Inc. ("SGM"), the Official Committee of Unsecured Creditors in Verity's bankruptcy cases (the "Committee"), and the California Attorney General (the "AG," and collectively, the "Parties") hereby enter into this stipulation (the "Stipulation") based on the following recitals of fact:

# **RECITALS**

- A. The Bankruptcy Court for the Central District of California entered three orders dated: (1) November 14, 2019 [Bankr. Doc. No. 3611] (the "November 14 Order"); (2) November 18, 2019 [Bankr. Doc. No. 3633] (the "November 18 Order"); and (3) November 27, 2019 [Bankr. Doc. No. 3724] (the "November 27 Order, and together with the November 14 and 18 Orders, the "Orders").
- B. SGM appealed the November 14 Order (2:19-cv-10352-DSF), the November 18 Order (2:19-cv-10354-DSF), and the November 27 Order (2:19-cv-10356-DSF) by filing notices of appeal (collectively, the "Appeals"). The Appeals are now pending before the United States District Court for the Central District of California.
- C. SGM filed and served its opening brief in the Appeals on February 14, 2020.
- D. On March 11, 2020, March 18, 2020, and March 27, 2020, the Parties filed stipulations to extend the time to file responsive and reply briefs [Doc. Nos. 47, 49 & 51]. The Court entered orders approving those stipulations [Doc. Nos. 48, 50 & 52].

- E. Pursuant to the *Order Approving Stipulation To Extend Time For The Filing Of Responsive And Reply Briefs* [Doc. No. 52], the current deadline for: (1) the Appellees to file their joint responsive brief (the "Responsive Brief") is April 6, 2020; and (2) SGM to file its reply brief (the "Reply Brief") is May 4, 2020.
- F. The AG has requested an additional one-week extension on the deadline to file the joint Responsive Brief given various sale motions filed in the Bankruptcy Court.
- G. The Committee and AG have communicated to SGM's counsel that the appellees require additional time to file the joint Responsive Brief.
- H. The Parties have agreed to: (1) extend the deadline for the Appellees to file their joint Responsive Brief to April 13, 2020; and (2) extend the deadline for SGM to file its Reply Brief to May 11, 2020.
- I. The Parties have agreed that this shall be the last extension of time for Appellees to file their joint Responsive Brief.

## **AGREEMENT**

**NOW, THEREFORE**, the parties to this Stipulation hereby agree and stipulate as follows:

- 1. The deadline for Appellees to file their joint Responsive Brief in the Appeals shall be extended from April 6, 2020 to April 13, 2020, and the deadline for SGM to file its Reply Brief shall be extended from May 4, 2020 to May 11, 2020.
- 2. No further briefing extensions for Appellees' Responsive Brief will be requested.
