1 The Court, having reviewed the *Second Stipulation Continuing Objection Deadline of the*  
2 *California Department of Health Care Services Related to the Proposed Transfer of the Medi-Cal*  
3 *Provider Agreement Related to Seton Medical Center* (the “Stipulation”),<sup>1</sup> filed as Docket No.  
4 4562, entered between the above-captioned debtors and debtors in possession (the “Debtors”), on  
5 the one hand, and the California Department of Health Care Services (“DHCS”), on the other  
6 hand, and good cause appearing therefor,


7 HEREBY ORDERS AS FOLLOWS:

- 8 1. The Stipulation is approved.
- 9 2. The Opposition Deadline, with respect to any objection by DHCS to the transfer of  
10 the Medi-Cal Provider Agreement pursuant to the Sale (an “Objection”), shall be continued from  
11 April 15, 2020, to April 29, 2020.
- 12 3. The Reply Deadline for any Objection shall be continued from April 20, 2020, to  
13 May 6, 2020.
- 14 4. A hearing on any Objection shall be May 13, 2020, at 10:00 a.m. (Pacific Time), or  
15 as soon thereafter as is convenient to the Court.
- 16 5. Nothing contained herein is a waiver of any rights, claims, interests, arguments, or  
17 contentions of the parties hereto regarding the subject matter hereof, or the Sale, and all such  
18 rights, claims, interests, arguments and contentions are expressly reserved.
