10 from June 16, 2020 to August 18, 2020, ~~at 10:00 a.m., with a Joint Status Report to be filed by no~~  
11 ~~later than August 11, 2020 or a date convenient to the Bankruptcy Court after August 18, 2020~~  
12 and (iii) all deadlines in the *Scheduling Order* [Docket No. 3] ~~are VACATED and updated~~  
13 ~~litigation deadlines will be set at the August 18, 2020 status conference extended in accordance~~  
14 ~~with the changed date of the status conference.~~


