Pursuant to the Fees Order, any party objecting to the allowance and payment of interim compensation and reimbursement of expenses as requested must file a written objection with the Court and serve a copy of that objection at the addresses shown above unless otherwise noted, upon (a) the Professional whose Monthly Fee Application is the subject of the objection, (b) the Office of

5 days of the date this Notice was mailed. Any objection must be a complete written statement of all
6 reasons in opposition thereto, declarations and copies of all evidence on which the objecting party
7 intends to rely, and any responding memorandum of points and authorities.

8 If an objection is timely filed and served, the Debtors will pay the Professional whose
9 application is the subject of an objection the amounts not in dispute at the times set forth in the Fees
10 Order with respect to the above professional and will reserve any amounts in dispute for payment
11 after the Court hears and resolves such dispute.
