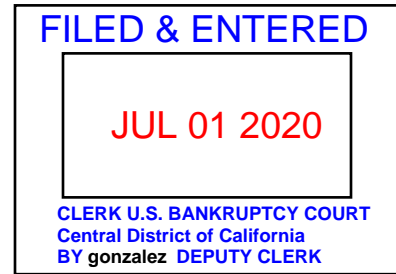

1 The Court, having reviewed the *Fourth Stipulation Continuing Objection Deadline of the*  
2 *U.S. Department of Health and Human Services and Centers for Medicare and Medicaid Services*  
3 *Concerning the Proposed Transfer of the Medi-Cal Provider Agreements Related to St. Francis*  
4 *Medical Center and Seton Medical Center* (the “Stipulation”),<sup>1</sup> filed as Docket No. 4983, entered  
5 between the above-captioned debtors and debtors in possession (the “Debtors”), on the one hand,  
6 and the U.S. Department of Health and Human Services and Centers for Medicare and Medicaid  
7 Services (“HHS”), on the other hand, and good cause appearing therefor,

8 HEREBY ORDERS AS FOLLOWS:

- 9 1. The Stipulation is approved.
- 10 2. The St. Francis Objection Deadline and the Seton Objection Deadline shall be  
11 continued from July 1, 2020 to July 15, 2020.
- 12 3. The St. Francis Reply Deadline and the Seton Reply Deadline for any St. Francis  
13 Objection or Seton Objection shall be continued from July 8, 2020 to July 22, 2020.
- 14 4. A hearing on any St. Francis Objection or Seton Objection shall be continued from  
15 July 15, 2020, at 10:00 a.m. (Pacific Time) to July 29, 2020, at 10:00 a.m. (Pacific Time).
- 16 5. Nothing contained herein is a waiver of any rights, claims, interests, arguments, or  
17 contentions of the parties hereto regarding the subject matter hereof, or the St. Francis Sale or the  
18 Seton Sale, and all such rights, claims, interests, arguments and contentions are expressly  
19 reserved.
- 20 6. As a result of the COVID-19 pandemic, the courtroom will be unavailable for in-  
21 court appearances at the continued hearing. All parties shall appear by telephone via CourtCall.  
22 To make a telephonic appearance, contact CourtCall at 888-882-6878, ext. 188 no later than one  
23 hour before the hearing.


