1 The Court, having reviewed the *Fourth Omnibus Stipulation Continuing Hearing and*
2 *Related Deadlines Concerning Objections to Cure Amounts and Other Assumption Issues Related*
3 *to the Proposed Sale of Assets Concerning Seton Medical Center* (the “Stipulation”),¹ filed as
4 Docket No. 4989, entered between Verity Health System of California, Inc. (“VHS”) and the
5 above-referenced affiliated debtors, the debtors and debtors in possession in the above-captioned
6 chapter 11 bankruptcy case (collectively, the “Debtors”), on the one hand, and the
7 “Counterparties”,² on the other hand, and good cause appearing,

8 HEREBY ORDERS AS FOLLOWS:

- 9 1. The Stipulation is approved.
- 10 2. The Objection Deadline for Counterparties to this Stipulation shall be continued
11 from July 1, 2020 to July 15, 2020.
- 12 3. The deadline to file any reply to an Objection filed by the Counterparties shall be
13 continued from July 8, 2020 to July 22, 2020.
- 14 4. The Hearing on any Objection filed by the Counterparties shall be continued from
15 July 15, 2020 at 10:00 a.m. to July 29, 2020 at 10:00 a.m.
- 16 5. As a result of the COVID-19 pandemic, the courtroom will be unavailable for in-
17 court appearances at the continued hearing. All parties shall appear by telephone via CourtCall.
18 To make a telephonic appearance, contact CourtCall at 888-882-6878, ext. 188 no later than one
19 hour before the hearing.

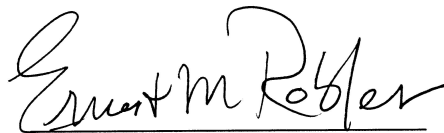
