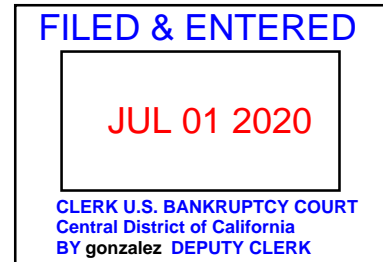

CONFERENCE AND STATUS  
CONFERENCE SET FOR JULY 14, 2020**

1 The Court, having reviewed the *Stipulation Regarding Pretrial Conference and Status*  
2 *Conference Set for July 14, 2020* (the “Stipulation”), filed as Docket No. 61, entered between the  
3 Official Committee of Unsecured Creditors of Verity Health System of California, Inc., *et al.* (the  
4 “Committee”), on the one hand, and U.S. Bank, National Association, not individually but in its  
5 respective capacities as Series 2015 Note Trustee and as Series 2017 Note Trustee (collectively, the  
6 “Notes Trustee”), on the other, and good cause appearing,


7 **HEREBY ORDERS AS FOLLOWS:**

- 8 1. The Stipulation is approved.
- 9 2. The Pretrial Conference set for July 14, 2020 at 11:00 AM shall be continued to  
10 October 13, 2020 at 10:00 AM. A Joint Pretrial Stipulation shall be filed on or before September 29,  
11 2020.
- 12 3. The Status Conference set for July 14, 2020 at 10:00 AM shall be continued to  
13 October 13, 2020 at 10:00 AM. A Joint Status Report shall be filed on or before October 6, 2020.
- 14 4. All Parties’ rights with respect to this Adversary Proceeding are expressly reserved.
- 15 5. As a result of the COVID-19 pandemic, the courtroom will be unavailable for in-court  
16 appearances at the Status Conference and Pretrial Conference. All parties shall appear by telephone  
17 via CourtCall. To make a telephonic appearance, contact CourtCall at 888-882-6878, ext. 188 no later  
18 than one hour before the hearing.
