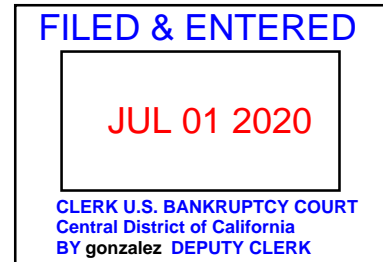

5 and good cause appearing,


6 **HEREBY ORDERS AS FOLLOWS:**

- 7 1. The Stipulation is approved.
- 8 2. The Pretrial Conference set for July 14, 2020 at 11:00 AM shall be continued to
9 October 13, 2020 at 10:00 AM. A Joint Pretrial Stipulation shall be filed on or before September 29,
10 2020.
- 11 3. The Status Conference set for July 14, 2020 at 10:00 AM shall be continued to
12 October 13, 2020 at 10:00 AM. A Joint Status Report shall be filed on or before October 6, 2020.
- 13 4. All Parties' rights with respect to this Adversary Proceeding are expressly reserved.
- 14 5. **As a result of the COVID-19 pandemic, the courtroom will be unavailable for in-court**
15 **appearances at the Status Conference and Pretrial Conference. All parties shall appear by telephone**
16 **via CourtCall. To make a telephonic appearance, contact CourtCall at 888-882-6878, ext. 188 no later**
17 **than one hour before the hearing.**
