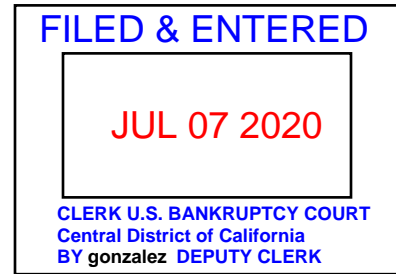

**ORDER APPROVING STIPULATION FOR

Debtors and Debtors In Possession.




1 The Court having considered the *Stipulation for Rejection of Hospital Services Agreement*
2 *with Cigna (St. Francis Medical Center)* filed on July 6, 2020 [Docket No. 5033] (the
3 “Stipulation”),¹ and good cause appearing therefor,

4 **IT IS HEREBY ORDERED** that:

- 5 1. The Stipulation is approved.
- 6 2. The Agreement is deemed rejected pursuant to Section 365(a) of the Bankruptcy
7 Code as of the Closing Date.
- 8 3. The last day for Cigna to file a claim, if any, arising from the rejection of the
9 Agreement under Bankruptcy Rule 3002(c)(4) shall be the later of (i) thirty (30) days from the date
10 of entry of this Order or (ii) thirty (30) days from the Closing Date, subject to extension with the
11 prior written consent of Hospital.
- 12 4. The Parties are authorized to take any and all further actions reasonably necessary to
13 effectuate the Stipulation.
- 14 5. The Court shall retain jurisdiction to hear and determine all matters arising from or
15 relating to this Order.
