**STATUS REPORT**

Defendants Verity Health System of California, Inc., Seton Medical Center, St. Vincent Medical Center, St. Vincent Dialysis Center, Inc., St. Francis Medical Center, Verity Holdings, LLC, DePaul Ventures, LLC (collectively, the “Debtor Defendants”), Defendants Richard Adcock and Steven Sharrer (collectively with the Debtor Defendants, the “Defendants”), and Plaintiff California Nurses Association (collectively with the Defendants, the “Parties”), have reached a settlement agreement (the “Settlement Agreement”) resolving this Adversary Proceeding in a mediation before the Honorable David H. Coar (ret.). The Parties intend to file a motion to approve the Settlement Agreement on or before August 14, 2020 (the “Motion”), pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure.
