24 The Court having considered the *Stipulation Extending Litigation Deadlines and*  
25 *Continuing Pre-Trial Conference and Trial Week Dates* ("**Stipulation**") the record in this  
26 case, and the Court finding notice of this matter is appropriate under the circumstances,  
27 for the reasons stated at the Conference and good cause appearing therefore:  
28


IT IS HEREBY ORDERED AS FOLLOWS:

1. The Stipulation is approved in its entirety;
2. Mediation shall be completed in this action by or before September 30, 2020;
3. If mediation is unsuccessful, Plaintiffs shall have 30 days from the conclusion of mediation to amend the First Amended Complaint, and Defendant shall have the later of 30 days from service of the Amended Complaint or 60 days from the conclusion of mediation to amend its Answer.
4. The Current Scheduling Order [Docket No. 54] is amended as follows:
  - a. The last day to complete discovery (except as to experts), including hearings on discovery motions is extended from September 18, 2020 to November 18, 2020;
  - b. The last day to disclose expert witness and expert witness reports is extended from September 23, 2020 to November 23, 2020;
  - c. The last day to disclose rebuttal expert witnesses and rebuttal expert witness reports is extended from October 22, 2020 to December 22, 2020;
  - d. The last day to complete discovery relating to expert witnesses, including hearings on motions related to expert discovery, is extended from November 23, 2020 to January 23, 2021;
  - e. The last day for dispositive motions to be heard is extended from November 5, 2020 to January 5, 2021;
  - f. The Pre-Trial Conference presently set for January 12, 2021 is continued to March 9 42, 2021, at 11:00 a.m.;
  - g. Trial, currently set for the week of January 25, 2021 is continued to the week of March 25, 2021. Parties and counsel shall appear personally in court unless otherwise ordered.
5. All other terms and deadlines set forth in the Current Scheduling Order are to remain in full force and effect;

1           6.       This order is without prejudice to any party to seek further deadline, Pre-Trial  
2 or Trial Week extensions for good cause shown.
