¹ Further, SGM appealed the Bankruptcy Court’s orders of November 14, November 18, and November 27, 2019 (the “Orders”) in the bankruptcy matter captioned *In re Verity Health System of California*, Bankr. C.D. Cal. Case No. 2:18-bk-20151-ER. This Court dismissed the Appeals as moot, and vacated the Orders on June 10, 2020. *See* [Dist. Doc. No. 65]. Verity has appealed this Court’s vacatur order; the appeal is pending before the Ninth Circuit Court of Appeals, and is assigned Case No. 20-55720.
