The Court, having reviewed the *Fourth Stipulation Continuing Hearing and Briefing Deadlines on Motion for Allowance of Administrative Expense Claim and Request for Payment under 11 U.S.C. § 503(b)* [Docket No. 6407] (the “Stipulation”)<sup>1</sup> entered into by and between Verity Health System of California, Inc. (“VHS”) and the above-referenced affiliated post-effective date debtors in the above captioned chapter 11 bankruptcy cases (collectively, the “Debtors”), on the one hand, and Creditor California Physicians’ Service dba Blue Shield of California (“Blue Shield” and, together with the Debtors, the “Parties”), on the other hand, and good cause appearing therefor,

HEREBY ORDERS AS FOLLOWS:

1. The Stipulation is APPROVED in its entirety.<sup>2</sup>
2. The Hearing on the Motion shall be continued from February 17, 2021, at 10:00 a.m. (Pacific Time), to March 17, 2021, at 10:00 a.m. (Pacific Time).
3. The Opposition Deadline shall be continued from February 3, 2021, to March 3, 2021.
4. The Reply Deadline shall be continued from February 10, 2021, to March 10, 2021.


<sup>2</sup> On February 2, 2021, the Court entered an order taking off calendar a motion filed by Smith & Nephew, Inc. which sought expedited payment of an ordinary-course Administrative Claim. *See* Docket No. 6409 (the “Order”). Among other things, the Order stated that the Court would “not conduct a hearing on any motion seeking expedited payment of an ordinary-course Administrative Claim.” Order at ¶ 2. On August 18, 2020, the Court entered an order [Docket No. 5538] approving a stipulation [Docket No. 5535] (the “Claim Stipulation”) fixing October 2, 2020 as the deadline for Blue Shield to file a motion seeking the allowance of “unpaid Post-Petition, Pre-Closing Overpayments.” Claim Stipulation at ¶ 4. The Motion referenced herein was filed pursuant to the Claim Stipulation and consequently does not qualify as a motion seeking expedited payment of an ordinary-course Administrative Claim. Therefore, the hearing on the Motion shall remain on calendar.
