On September 1, 2021 at 10:00 a.m., the Court conducted a hearing on the *Statement of QuadraMed Affinity Corporation and Picis Clinical Solutions Inc. in Support of Administrative Expense Claim* [Doc. No. 6613] (the "Motion"). For the reasons set forth in the Court's amended tentative ruling [Doc. No. 6640] (the "Ruling"), incorporated herein by reference, **IT IS HEREBY ORDERED AS FOLLOWS:** 

- 1) A continued hearing on the Motion is set for November 10, 2021 at 10:00 a.m.
- 2) No later than **October 20, 2021**, Claimants<sup>1</sup> shall submit a supplemental brief addressing the issues set forth in the Ruling. The Liquidating Trustee's opposition to Claimants' supplemental brief shall be filed no later than **October 27, 2021**.
- 3) No later than **September 30, 2021**, the parties shall have completed one day of mediation. Mediation of the issues raised by the Motion shall be combined with the mediation that has already been ordered by the Court in the preference action captioned *Liquidating Trustee v. QuadraMed Corporation* [Adv. No. 2:20-ap-01388-ER]. The mediation may be conducted by the mediator that has already been appointed in the preference action; in the alternative, the parties are free to select a different mediator with the expertise to address both the issues raised in the Motion and the preference action. The manner in which the mediation is conducted—whether in-person or by videoconference—shall be at the discretion of the mediator.

IT IS SO ORDERED.
