For the reasons set forth in the concurrently-issued *Amended Memorandum of Decision on Motions Filed by the Retirement Plan for Hospital Employees* (the "Amended Memorandum"), the Court **HEREBY ORDERS AS FOLLOWS:**

- 1) The Plan Enforcement Motion¹ is **DENIED**.
- 2) RPHE holds an allowed administrative claim under § 503(b) of the Bankruptcy Code in the amount of \$2,193,132.00 on account of the normal and administrative costs of the RPHE pension plan. RPHE is **NOT** entitled to an administrative claim on account of the RPHE pension plan's underfunding costs, which total \$23,557,593.00.
