For the reasons set forth in the concurrently-issued *Memorandum of Decision Granting in Part Prime Healthcare Services, Inc.'s Motion to Enforce Asset Purchase Agreement* (the "Memorandum"), the Court **HEREBY ORDERS AS FOLLOWS:** 

- 1) Pursuant to the Reconciliation Process,<sup>1</sup> Prime is authorized to retain \$23,157,581 in QAF VI Seller Net Payments.
- 2) No later than **November 19, 2021**, the Liquidating Trustee and Prime shall have completed one day of mediation with respect to the dispute concerning Prime's alleged failure to collect \$5,105,731 in Accounts Receivable.
- To the extent the mediation does not result in a settlement, by no later than December 3, 2021, each party shall file a statement setting forth the (a) the issues that remain in dispute and (b) the party's position with respect to each remaining disputed issue.
- 4) A continued hearing on the Motion shall be held on December 8, 2021 at 10:00 a.m. Parties may appear at the continued hearing either in-person or by telephone. Parties electing to appear in-person shall comply with all requirements regarding social distancing, use of face masks, etc. which may be in effect at the time of the hearing. Parties electing to appear by telephone should contact CourtCall at 888-882-6878 no later than one hour before the hearing.
