The Bankruptcy Court has set a deadline of **July 29, 2020** (the "<u>Administrative Expense</u> <u>Claims Bar Date</u>"), for holders of Administrative Expense Claims (as defined herein) against Verity Health System of California, Inc., a California nonprofit benefit corporation and the Debtor herein, and the above-referenced affiliated debtors, the debtors and debtors in possession in the abovecaptioned chapter 11 bankruptcy cases (collectively, the "<u>Debtors</u>"), to assert an Administrative Expense Claim against the Debtors' estates. *See* Docket No. 4997.
