- 1. On June 9, 2020 (the "Petition Date"), the Debtors each filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") commencing the above captioned cases (the "Chapter 11 Cases"). The Debtors continue to manage and operate their businesses as debtors-in-possession pursuant to Bankruptcy Code Sections 1107 and 1108.
- 2. On June 23, 2020, an official committee of unsecured creditors (the "<u>Committee</u>") was appointed in these Chapter 11 Cases. No trustee or examiner has been requested or appointed in these Chapter 11 Cases.
- 3. On September 16, 2020, the Debtors filed the Lewis Energy 9019 Motion and the Consultants Retention Application.
- 4. In light of the Debtors' urgent need for the services to be provided by the consultants under the Consultants Retention Application and the Debtors' desire to finalize the settlement described in the Lewis Energy 9019 Motion prior to the October 1, 2020 confirmation hearing, the Debtors request that the Consultants Retention Application and the Lewis Energy 9019 Motion be heard on an expedited basis at the hearing scheduled for **September 24, 2020, at 1:30 p.m. Central Time**. - 5. Notice of this Motion to Expedite will be provided to the parties listed on the Debtors' service list in accordance with the *Order Granting Complex Chapter 11 Bankruptcy Case*

Treatment (collectively, the "Notice Parties").

6. WHEREFORE the Debtors respectfully requests that the Court (i) grant the Motion to Expedite and (ii) grant such other and further relief as is just and proper.
