# ORDER GRANTING EIGHTH EXTENSION OF CLAIM OBJECTION DEADLINE AND INITIAL DISTRIBUTION DEADLINE FOR GENERAL UNSECURED CLAIMS

Upon the Eighth Motion of the Litigation Trustee for Order Extending Claim Objection Deadline and Initial Distribution Deadline for General Unsecured Claims [Docket No. 1043] (the "Motion")<sup>2</sup> filed by Ankura Trust Company, LLC (the "Trustee"), as Litigation Trustee and

Disbursing Agent with respect to the General Unsecured Claims; the Court having reviewed the Motion; and the Court finding that (i) it has jurisdiction over the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) proper and adequate notice of the Motion and the opportunity for a hearing thereon has been given under the circumstances and no other or further notice is necessary; and (iv) upon the record herein and after due deliberation thereon, good and sufficient cause exists for granting the relief requested in the Motion, as set forth herein.

#### Accordingly, IT IS HEREBY ORDERED as follows:

- 1. ORDERED that the Motion is GRANTED; and it is further
- 2. ORDERED that the Claim Objection Deadline for General Unsecured Claims is hereby extended through and including July 31, 2024, without prejudice to the right of the Trustee to seek further extensions of time; and it is further
- 3. ORDERED that the Distribution Deadline for General Unsecured Claims (other than Term Loan Lender Class 6 Creditors) is hereby extended through and including July 31, 2024, without prejudice to the right of the Trustee to seek further extensions of time; and it is further
- 4. ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from and related to the entry of this Order.
