ORDER GRANTING MOTION FOR EMERGENCY HEARING DEBTORS' MOTION FOR AN ORDER (I) SHORTENING THE BAR DATE FOR FILING PROOFS OF CLAIM, (II) ESTABLISHING RAMIFICATIONS FOR FAILURE TO TIMELY FILE CLAIMS, (III) APPROVING NOTICE OF SHORTENED BAR DATE, AND (IV) APPROVING THE MAILING OF NOTICES

Failure to Timely File Claims, (III) Approving Notice of Shortened Bar Date, and (IV) Approving the Mailing of Notices (the "Motion to Expedite"),² filed by Vista Proppants and Logistics, LLC, et al. (collectively, the "Debtors"). The Court finds that good and sufficient cause exists to grant the relief requested in the Motion to Expedite.
