ORDER (I) SHORTENING THE BAR DATE FOR FILING PROOFS OF CLAIM, (II) ESTABLISHING RAMIFICATIONS FOR FAILURE TO TIMELY FILE CLAIMS; (III) APPROVING CONSOLIDATED NOTICE OF SHORTENED BAR DATE, AND (IV) **APPROVING THE MAILING OF NOTICES**

Upon consideration of the Debtors' Emergency Motion for Order (I) Shortening the Bar

Date for Filing Proofs of Claim, (II) Establishing Ramifications for Failure to Timely File

Claims; (III) Approving Consolidated Notice of Shortened Bar Date, and (IV) Approving the Mailing of Notices (the "Motion"),² filed by Vista Proppants and Logistics, LLC and its debtor affiliates, as debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the "Debtors"); and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334, and the Order of Reference of Bankruptcy Cases and Proceedings Nunc Pro Tunc, Miscellaneous Rule No. 33 (N.D. Tex. August 3, 1984); and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing that venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided, and it appearing that no other or further notice need be provided; and the Court having reviewed the Motion; and the Court having held a hearing on the Motion; and upon all of the proceedings had before the Court and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

- 1. The Motion is GRANTED.
- 2. The last day for any person or entity, excluding governmental units, to file a proof of claim in the above-captioned chapter 11 cases is **August 31, 2020** (the "<u>Bar Date</u>" or the "<u>Shortened Bar Date</u>"), except as otherwise provided in this Order.³
- 3. The form of notice of Shortened Bar Date, attached hereto as **Exhibit 1** (the "Notice of Shortened Bar Date") is incorporated herein by reference and approved.
 - 4. Within seven (7) days of the entry of this Order, KCC shall serve the Notice of

Shortened Bar Date, by United States mail, first class postage prepaid, at the expense of the estate, to all of the following whose addresses are known by the Debtors:

- a. all known creditors;
- b. all known shareholders of the Debtors of record as of the Petition Date;
- c. all parties that have requested notice in the Chapter 11 Cases; and
- d. all other parties-in-interest as required by Bankruptcy Rule 2002.
- 5. The Debtors shall publish the form of notice of Shortened Bar Date attached hereto as **Exhibit 2**, in the national edition of one of the following newspapers: The Wall Street Journal, The New York Times, or USA Today, at least once, not later than twenty-one (21) days prior to the Shortened Bar Date.
- 6. A proof of claim will be deemed timely and properly filed if it is filed with KCC or the Clerk of the United States Bankruptcy Court for the Northern District of Texas, so that it is actually received by no later than August 31, 2020 as established by this Order.
- 7. The following persons or entities are **not** required to file a proof of claim on or before the Bar Date:
 - a. any person or entity that has already properly filed, with KCC or the Clerk of the United States Bankruptcy Court for the Northern District of Texas, a proof of claim against the Debtors using a claim form that substantially conforms to Official Form 410;
 - b. any person or entity (i) whose claim against a Debtor is not listed as "disputed," "contingent," or "unliquidated," in the Schedule of the applicable Debtor and (ii) who agrees with the nature, classification, and amount of its claim as identified in the Schedule of the applicable Debtor; or
 - c. any entity whose claim against a Debtor has previously been allowed by, or paid pursuant to, an order of the Court.
- 8. Notwithstanding anything contained herein to the contrary, this Order does not affect the deadline for filing claims arising from rejection of executory contracts or unexpired

leases pursuant to section 365 of the Bankruptcy Code.

- 9. If an amendment to the bankruptcy schedules of assets and liabilities (the "Schedules") reduces the liquidated amount of a scheduled claim, or reclassifies a scheduled, undisputed, liquidated or non-contingent claim as disputed, unliquidated, or contingent, the affected claimant may file a proof of claim on the <u>later</u> of (i) the Bar Date or (ii) thirty (30) days after the mailing of the notice of such amendment.
- 10. Neither the Bar Date nor any other deadline established in this Order applies to requests for the payment of administrative expenses arising in this case under sections 503, 507(a)(1), 330(a), 331, and/or 364 of the Bankruptcy Code.
- 11. Holders of equity securities of the Debtors need not file a proof of interest; provided, however, that an equity security holder must file a proof of claim to the extent that such equity security holder asserts any rights as a creditor against the Debtors.
- 12. If a person or entity is required to file a timely proof of claim in the form and manner specified by this Order, and such person or entity fails to do so on or before the Bar Date associated with such claim, then, except as otherwise provided under applicable law or by order of this Court, any claim of such creditor is discharged, and such person or entity is forever barred from (a) asserting its claim, whether directly or indirectly, against the Debtors or their property (or filing a proof of claim with respect thereto), (b) participating in any distribution in the Chapter 11 Cases on account of such claim, (c) voting with respect to any chapter 11 plan or plans filed in the Chapter 11 Cases, and (d) receiving any distribution under any such chapter 11 plan or plans. In addition, such creditor need not receive any further notices regarding its claim and will be bound by the terms of any chapter 11 plan or plans that may be confirmed in the Chapter 11 Cases.

On June 9, 2020 (the "<u>Petition Date</u>"), Vista Proppants and Logistics, LLC and its debtor affiliates, as debtors and debtors in possession (the "<u>Debtors</u>"), filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101 through 1330 (the "<u>Bankruptcy Code</u>") in the United States Bankruptcy Court for the Northern District of Texas, Fort Worth Division (the "<u>Court</u>") commencing the above-captioned chapter 11 cases (the "<u>Chapter 11 Cases</u>").

SHORTENED BAR DATE. The Debtors filed their Schedules of Assets and Liabilities on July 23, 2020 (the "<u>Schedules</u>"). The Schedules may be amended from time to time. Pursuant to Bankruptcy Rule 3003(b)(2), it is not necessary for an equity security holder to file a proof of interest based solely upon such interest; <u>provided</u>, <u>however</u>, that if an equity holder asserts any rights as a creditor of the Debtor, a proof of claim is required, except as set forth herein.
