COMES NOW, Tom Weiskotten and GR Robbins & Associates, P.A. and respectfully shows unto this Court as follows:


1. This case was converted to Chapter 7 on February 21, 2017 and Andre M. Toffel was appointed as Trustee.

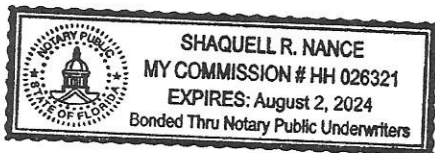
