(“WMI”), one of the above-captioned debtors and debtors-in-possession, filed its *Schedule of Assets and Liabilities* [Docket No. 477] (the “Schedules”) and *Statement of Financial Affairs* (the “SOFAs”) [Docket No. 478], as subsequently amended, with the United States Bankruptcy Court for the District of Delaware, 824 North Market Street, 3rd Floor, Wilmington, Delaware 19801 (the “Bankruptcy Court”).

PLEASE TAKE FURTHER NOTICE that, on February 24, 2009, WMI filed its *Second Amended Schedule of Assets and Liabilities* (the “Amended Schedules”) [Docket No. 709] and *Second Amended Statement of Financial Affairs* [Docket No. 710] with the Bankruptcy Court. The Amended Schedules modify, among other things, certain claims identified in Schedule F (Creditors Holding Unsecured Non-Priority Claims) (the “Schedule F Amendment”). A list of the claimants affected by the Schedule F Amendment is annexed hereto as Exhibit A.

PLEASE TAKE FURTHER NOTICE that, pursuant to the *Order Pursuant to Section 502(b)(9) of the Bankruptcy Code, Bankruptcy Rules 2002(a)(7), (f), (l), and 3003(c)(3), and Local Rule 2002-1(e) Establishing Deadline For Filing Proofs of Claims and Approving the Form and Manner of Notice Thereof* [Docket No. 632], entered by the Bankruptcy Court on January 30, 2009, if any of the claimants affected by the Schedule F Amendment listed on Exhibit A hereto disagree with the nature, amount or classification of their claim(s), then such claimant must file a proof of claim form with respect to such claim(s) no later than **5:00 p.m. (Eastern Daylight Time) on March 31, 2009** (the "Bar Date"). The Debtors shall provide notice of the Schedule F Amendment and a proof of claim to each of the parties identified on Exhibit A.
