FIRST INTERIM APPLICATION OF HOULIHAN LOKEY CAPITAL, INC., INVESTMENT BANKER TO THE DEBTORS, FOR INTERIM ALLOWANCE OF COMPENSATION FOR PROFESSIONAL SERVICES RENDERED AND REIMBURSEMENT OF ACTUAL AND NECESSARY EXPENSES INCURRED FROM NOVEMBER 25, 2018 THROUGH MARCH 31, 2019

TO THE HONORABLE STUART M. BERSTEIN, UNITED STATES BANKRUPTCY JUDGE:

Houlihan Lokey Capital, Inc. ("Houlihan Lokey"), as investment banker to the debtors and debtors in possession in the above-captioned cases (collectively, the "Debtors"), hereby submits this first application (the "Application"), pursuant to sections 327(a) and 328 of title 11 of the United States Code (the "Bankruptcy Code"), Rules 2014 and 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules of the Southern District of New York (the "Local Rules"), the Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases, dated June 17, 2013 (the "Local Guidelines"), the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed

Under 11 U.S.C. § 330, effective November 1, 2013 (the "U.S. Trustee Guidelines," and collectively with the Local Guidelines, the "Fee Guidelines"), and the Order Establishing Procedures for Interim Compensation And Reimbursement Of Expenses Of Professionals, dated December 23, 2018 (Docket No. 250) (the "Interim Compensation Order"), for the allowance of interim compensation for professional services rendered from November 25, 2018 through and including March 31, 2019 (the "First Interim Compensation Period"), and for reimbursement of expenses incurred in connection with such services, and in support thereof respectfully represents as follows:

BACKGROUND

- 1. <u>Bankruptcy Filing</u>. On November 25, 2018 (the "<u>Petition Date</u>"), the Debtors commenced the above-captioned chapter 11 cases in this Court. The Debtors' chapter 11 cases have been consolidated for procedural purposes and are being jointly administered pursuant to Rule 1015(b) of the Bankruptcy Rules. The Debtors are authorized to operate their businesses and manage their properties as debtors in possession pursuant to section 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner has been appointed in the chapter 11 cases.
- 2. <u>Jurisdiction</u>. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. Venue of the chapter 11 cases is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding under 28 U.S.C. § 157(b)(2). The statutory predicates for the relief sought herein are sections 330 and 331 of the Bankruptcy Code. Pursuant to the Local Guidelines, a certification regarding compliance with the Fee Guidelines is attached hereto as <u>Exhibit B</u>.

RETENTION OF HOULIHAN LOKEY AND SUMMARY OF PROFESSIONAL COMPENSATION AND REIMBURSEMENT OF EXPENSES REQUESTED

- 3. Before the Petition Date, in April 2018, the Debtors engaged Houlihan Lokey to provide investment banking and advisory services in connection with a potential financial restructuring or reorganization of the Debtors. On January 18, 2019, pursuant to the Order Authorizing the Debtors to Retain Houlihan Lokey as Investment Banker *nunc pro tunc* to the Petition Date Docket No.290 (the "Retention Order"), the Court authorized Houlihan Lokey's retention as an investment banker to the Debtors in these cases. The Retention Order authorized Houlihan Lokey to receive compensation as outlined in the Debtor's application to retain Houlihan Lokey Docket No.166 (the "Retention Application") pursuant to the procedures set forth in the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, the Fee Guidelines, and orders of this Court.
- 4. The terms and conditions of Houlihan Lokey's engagement in these cases, which are embodied in the Retention Application and approved by the Court, are based upon Houlihan Lokey's agreement with the Debtors executed May 1, 2018 (the "Engagement Letter"). Pursuant to the Engagement Letter, Houlihan Lokey is to be compensated through a Monthly Retainer Fees of \$175,000.00, plus as applicable, Transaction Fee(s) (as defined in section 5 of the Engagement Letter).
- 5. In addition, the Engagement Letter entitles Houlihan Lokey to receive reimbursement of all actual and reasonable out-of-pocket expenses.
- 6. Houlihan Lokey's fees, including the Monthly Retainer Fees and Transaction Fees, were approved pursuant to the Houlihan Lokey Retention Order, and Houlihan Lokey was authorized to be compensated and reimbursed in accordance with the terms of, and at the times

specified by, the Engagement Letter. As specified in the Engagement Letter and in accordance with the order approving the Macquarie Sale Transaction Docket No. 444, a portion of the net sale proceeds of the sale to Macquarie and funds in the Fee Reserve Account were used to pay Houlihan Lokey's Sale Transaction Fee and Financing Transaction Fee (as both defined in the Engagement Letter) in the amounts of \$8,745,311.00 and \$735,000.00, respectively, upon the closing of the Macquarie sale on March 13, 2019. Houlihan Lokey will seek Court approval of the Sale Transaction Fee and Financing Transaction Fee in its final fee application.

- 7. Houlihan Lokey prepared this Application in accordance with the Fee Guidelines and a certification regarding compliance is attached hereto as <u>Exhibit B</u>. Houlihan Lokey believes that this Application, together with the attachments hereto, substantially complies in all material respects with the Fee Guidelines. To the extent this Application does not comply in every respect with the requirements of such Fee Guidelines, Houlihan Lokey respectfully request a waiver for any such technical non-compliance.
- 8. By this Application, Houlihan Lokey seeks allowance of the interim compensation for professional services rendered to the Debtors' in the aggregate amount of \$700,000.00, of which \$280,000.00 remains unpaid, and for the reimbursement of expenses incurred in connection with the rendition of services in the aggregate amount of \$52,032.27, of which \$6,137.04 remains unpaid, during the First Interim Compensation Period.
 - a) In accordance with the Interim Compensation Order, Houlihan Lokey submitted monthly fee statements to the Court seeking interim compensation and reimbursement of expenses. During the First Interim Compensation Period, Houlihan Lokey submitted the following fee statements:

- i. On February 1, 2019, pursuant to the Interim Compensation Order, Houlihan Lokey served its first fee statement for the period of November 25, 2018 through and including December 31, 2018 (the "First Monthly Fee Statement"). The First Monthly Fee Statement sought (i) allowance of \$175,000.00 as compensation for services rendered (which was the total monthly fee for December 2018) and (ii) the reimbursement of \$19,316.46 in expenses. As of the date hereof, Houlihan Lokey has received a \$159,316.46 payment in regard to the First Monthly Fee Statement.
- ii. On March 1, 2019, pursuant to the Interim Compensation Order, Houlihan Lokey served its second fee statement for the period of January 1, 2019 through and including January 31, 2019 (the "Second Monthly Fee Statement"). The Second Monthly Fee Statement sought (i) allowance of \$175,000.00 as compensation for services rendered (which was the total monthly fee for January 2019) and (ii) the reimbursement of \$15,102.01 in expenses. As of the date hereof, Houlihan Lokey has received a \$155,102.01 payment in regard to the Second Monthly Fee Statement.
- iii. On April 3, 2019, pursuant to the Interim Compensation Order, Houlihan Lokey served its third fee statement for the period of February 1, 2019, through and including February 28, 2019 (the "Third Monthly Fee Statement"). The Third Monthly Fee Statement sought (i) allowance of \$175,000.00 as compensation for services rendered (which was the

total monthly fee for February 2019) and (ii) the reimbursement of \$11,476.76 in expenses. As of the date hereof, Houlihan Lokey has received a \$151,476.76 payment in regard to the Third Monthly Fee Statement. Houlihan Lokey was overpaid by \$1,204.30, in relation to expense reimbursement, such amount has been reflected in the total relief requested on account of expense reimbursement.

- iv. On May 2, 2019, pursuant to the Interim Compensation Order, Houlihan Lokey served its fourth fee statement for the period of March 1, 2019 through and including March 31, 2019 (the "Fourth Monthly Fee Statement"). The Fourth Monthly Fee Statement sought (i) allowance of \$175,000.00 as compensation for services rendered (which was the total monthly fee for March 2019) and (ii) the reimbursement of \$7,341.34 in expenses. As of the date hereof, Houlihan Lokey has not received payment in regard to the Fourth Monthly Fee Statement.
- 9. Pursuant to Bankruptcy Rule 2016(a), there is no agreement or understanding between Houlihan Lokey and any other person for the sharing of compensation to be received for services rendered in these cases.
- 10. Houlihan Lokey respectfully submits that (a) the services provided by Houlihan Lokey were necessary for, and beneficial to, the Debtors, (b) Houlihan Lokey has satisfied the requirements of Sections 328(a) of the Bankruptcy Code as set forth in the Retention Order, and (c) the requested compensation is appropriate based on the complexity, importance and nature of the services provided.

- 11. Under the Retention Order, Houlihan Lokey is compensated on a flat monthly and transactional, as opposed to hourly, fee basis, reflecting a typical fee structure for Houlihan Lokey and other leading investment banking firms. Pursuant to the Retention Order, in light of services already provided by Houlihan Lokey, the services to be provided by Houlihan Lokey and the structure of Houlihan Lokey's compensation pursuant to the Engagement Letter, Houlihan Lokey and its professionals are excused from the requirement to maintain or provide detailed time records as set forth in the Bankruptcy Rules and Fee Guidelines; provided, however, that notwithstanding that Houlihan Lokey does not charge for its services on an hourly basis, Houlihan Lokey will nonetheless maintain reasonably detailed time records in 0.5 hour increments containing descriptions of services rendered to the Debtors after the entry of the Retention Order. For the convenience of the Court and all parties in interest, and in accordance with paragraph 8 of the Retention Order, attached hereto as Exhibit C is a summary setting forth estimated hours worked by professional by work category for the First Interim Compensation Period. Since Houlihan Lokey does not have the IT systems in place to allow its professional staff to regularly log hours worked, the hours logged are estimates only and Houlihan Lokey believes the actual hours worked are likely understated.
- 12. For the avoidance of doubt, pursuant to the Retention Order, Houlihan Lokey is not required to provide any time records for services rendered prior to the entry of the Retention Order on a final, unappealable basis.
- 13. Annexed hereto as <u>Exhibit D</u> is a schedule specifying the categories of expenses for which Houlihan Lokey is seeking reimbursement and the total amount of expenses in each category as well as the detailed expenses by month.

SUMMARY OF SERVICES RENDERED

- 14. Before the Petition Date, in April 2018, the Debtors engaged Houlihan Lokey as their primary investment banker to provide investment banking and advisory services in connection with a potential financial restructuring or reorganization of the Debtors. Since being engaged, Houlihan Lokey has provided the Debtors with investment banking services, including (a) reviewing and analyzing the Debtors' assets and operations; (b) evaluating the Debtors' nearterm liquidity and revenue sensitivities; (c) developing a financial model to evaluate strategic alternatives and potential outcomes; (d) presenting to the Debtors' Board of Directors (the "Board of Directors"), existing equity Sponsors (the "Sponsors"), the steering committee (the "Steering Committee") of certain secured lenders under the Debtors' existing WAC Facilities (each a "WAC Facility" and the lenders thereunder, "WAC Facility Lenders"), original equipment manufacturers, and other third parties; (e) rendering strategic advice to the Debtors and participating in meetings and negotiations with the creditors and WAC Facility Lenders; and (f) advising the Debtors on the indications of interest and proposals regarding any transactions involving current and/or potential lenders, equity investors, acquirers and/or strategic partners. In addition to the foregoing, Houlihan Lokey expended considerable time prior to the Petition Date assisting the Debtors in the successful negotiation of multiple forbearance agreements under the WAC Facilities, running a comprehensive sale, and marketing process for substantially all of the Debtors' assets.
- 15. During the First Interim Compensation Period, the following professionals in Houlihan Lokey's Los Angeles office performed substantial services to the Debtors in this case:

Matthew R. Niemann – Managing Director Jeff Raithel – Director Matthew Braun – Senior Vice President Daniel Kim – Vice President Mackenzie Maynard – Financial Analyst 16. The following summarizes the significant professional services by category rendered by Houlihan Lokey during the First Interim Compensation Period.

Analysis, Presentations, and Due Diligence

17. Houlihan Lokey spent a significant amount of time during the First Interim Compensation Period (a) facilitating due diligence for Macquarie Rotorcraft Leasing LLC ("Macquarie") and WAC Lenders, and (b) analyzing the Macquarie bid and credit bids on behalf of the Debtors. Houlihan Lokey participated in numerous calls with the Debtors' management and other retained professionals, Weil, Gotshal & Mange LLP ("Weil") and FTI Consulting Inc. ("FTI") and has prepared and delivered multiple presentations to the Debtors on these topics.

Correspondence with Creditors, and Advisors

- 18. During the First Interim Compensation Period, Houlihan Lokey participated in numerous calls with WAC Lenders and/or their advisors on a number of matters, including due diligence, business plan update, exit payment negotiations, execution of funds flow and other issues/questions of the cases.
- 19. During the First Interim Compensation Period, Houlihan Lokey continued to manage WAC specific online data rooms pursuant to the terms of the Bidding Procedures Order.

Hearings, Administrative, and Other

20. Houlihan Lokey expended time on administrative matters including, but not limited to, preparing for and attending court hearings, managing the Debtor's online data rooms and facilitating other communication and documentation between interested parties. Houlihan Lokey was present in the Debtor's court hearings to provide facts and expert testimony if called upon. Houlihan Lokey also coordinated any such services performed at the Debtor's request with services of any other advisors and counsel, as appropriate, in an effort to avoid duplication of

efforts. In addition, Houlihan Lokey continued to manage WAC specific online data rooms pursuant to the terms of the Bidding Procedures Order.

- 21. In connection with Houlihan Lokey's retention, Houlihan Lokey financial staff also performed a comprehensive review of potential conflicts with various parties-in-interest in the case. The conflicts check was also reviewed by Houlihan Lokey's legal department.
- 22. The professional services performed by Houlihan Lokey were necessary and appropriate to the administration of the Chapter 11 Cases and were in the best interests of the Committee and other parties in interest. Compensation for the services described above is commensurate with the complexity, importance, and nature of the problems, issues, or tasks involved.

ACTUAL AND NECESSARY DISBURSEMENTS OF HOULIHAN LOKEY

23. Houlihan Lokey disbursed \$52,032.27 as expenses incurred in providing professional services during the First Interim Compensation Period. It is Houlihan Lokey's policy to charge its clients for all actual and necessary expenses incurred in connection with the engagement. The expenses charged to clients include, among other things, telephone charges, document processions, travel expenses, expense for "working meals," and computerized research. In accordance with the applicable factors enumerated in the Bankruptcy Code, it is respectfully submitted that the amount requested by Houlihan Lokey is fair and reasonable given (a) the complexity of these cases, (b) the time expended, (c) the nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under this title.

THE REQUESTED COMPENSATION SHOULD BE ALLOWED

24. Houlihan Lokey respectfully submits that the services for which it seeks compensation in the Application were necessary for, and beneficial to, the Debtors and that

Houlihan Lokey has satisfied the requirements of sections 327(a) and 328 of the Bankruptcy Code as set forth in the Retention Order. Houlihan Lokey's requested compensation is appropriate based on the complexity, importance and nature of the services provided, and is consistent with the customary compensation charged by comparable professionals both in and out of the bankruptcy context. Houlihan Lokey therefore respectfully requests that the Court grant the relief requested in this Application.

NO DUPLICATION OF SERVICE

25. Houlihan Lokey has developed a cooperative working relationship on behalf of the Debtors with Weil as the Debtors' counsel, FTI as the Debtors' financial advisor, and Accenture LLP, successor in interest to Seabury Corporate Advisors LLC (collectively "Seabury Consulting") as the Debtors' corporate advisor. Because each firm was aware of the others' role and services to the Debtors, Houlihan Lokey believe that no unnecessary duplication of services occurred.

NO PRIOR REQUEST

26. No previous motion for the relief sought herein has been made to this or any other court.

expenses incurred be without prejudice of Houlihan Lokey's right to seek additional compensation

the time of this Application; and (iii) such other and further relief as is just and proper, and (b)

granting any such and further relief as the Court may deem proper.
