Counsel to Plaintiff Macquarie Rotorcraft Leasing in the above-captioned matter, Mark Pollack and Michael Whalen (both admitted pro hac vice), request leave to make a "live" telephonic appearance on September 17, 2019 at 12:00 noon for the presentment of Defendant LCI Helicopter's proposed order of dismissal, filed yesterday (ECF No. 15). Macquarie is still evaluating its response to LCI's proposed order. Counsel to Macquarie must confer with client representatives located in Australia in advance of responding to LCI's proposed order by way of agreement, objection, or counter-proposal.

Any objection or counter-submission by Macquarie to LCI's proposed order is due by Monday, September 16, 2019. The Court's practice guidelines require that all requests for "live" telephonic appearances be made two business days prior to the hearing. While counsel may determine that appearing in person for presentment is necessary in order to present any objection or counter-proposal to LCI's proposed order, it seeks leave to appear by telephone in the event Macquarie's response or objection to LCI's proposed order is such that the expense of an in-person appearance (counsel is located in Chicago) is not warranted. Counsel submits that there is good cause for the leave requested herein.
