BACKGROUND

- 1. On November 25, 2018, the Debtors each commenced with the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court") a voluntary case under chapter 11 of the Bankruptcy Code. The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee, examiner, or statutory committee of creditors has been appointed in these Chapter 11 Cases. The Debtors' Chapter 11 Cases are being jointly administered for procedural purposes only pursuant to Bankruptcy Rule 1015(b).
- 2. On July 22, 2019, the Debtors filed the *Third Amended Chapter 11 Plan of Liquidation of Waypoint Leasing Holdings Ltd. and Its Affiliated Debtors* [ECF No. 871] (the "**Plan**"). On July 31, 2019, the Bankruptcy Court entered the *Findings of Fact, Conclusions of Law, and Order Confirming Third Amended Chapter 11 Plan of Liquidation of Waypoint Leasing Holdings Ltd. and Its Affiliated Debtors* [ECF No. 893] (the "**Confirmation Order**").
- 3. In accordance with the Confirmation Order, the Debtors filed the *Notice of*(I) Entry of Order Confirming Third Amended Chapter 11 Plan of Liquidation of Waypoint
 Leasing Holdings Ltd. and Its Affiliated Debtors and (II) Occurrence of Effective Date [ECF
 No. 914], noting that the Plan went effective on August 9, 2019. On the effective date of the Plan,
 William Transier assumed his role as the plan administrator in accordance with the Plan.
- 4. On December 13, 2019, the Bankruptcy Court entered the *Order Granting* the Motion of the Debtors for Entry of a Final Decree Closing Certain of the Debtors' Chapter 11 Cases [ECF No. 1025] (the "**First Final Decree**"), providing for the closing of sixty-one (61) of the Debtors' Chapter 11 Cases.
- 5. On March 20, 2020, the Bankruptcy Court entered the *Order Granting the Motion of the Debtors for Entry of a Final Decree Closing Certain of the Debtors' Chapter 11*

Cases [ECF No. 1047] (the "Second Final Decree", together with the First Final Decree, the "Final Decrees"), providing for the closure of an additional forty (40) of the Debtors' Chapter 11 Cases. Following entry of the Final Decrees, nine (9) of the Debtors' Chapter 11 Cases remain open.

- 6. This Report is unaudited, limited in scope, covers a limited time period, and has been prepared solely for the purpose of complying with the post-confirmation quarterly reporting obligations required by the Office of the United States Trustee and the Bankruptcy Court. This Report is not intended to be relied upon as a complete description of the Debtors.
