**CERTIFICATION OF COUNSEL REGARDING PROPOSED ORDER APPROVING
SECOND INTERIM FEE APPLICATIONS OF THE COMMITTEE PROFESSIONALS
FOR THE PERIOD FROM JANUARY 1, 2019 THROUGH MARCH 31, 2019**

The undersigned hereby certifies as follows:

1. On May 15, 2019, the Official Committee of Unsecured Creditors of Welded Construction, L.P., *et al.* (the “Committee”) filed the:

- Second Interim Application of Teneo Capital LLC for Compensation for Services Rendered and Reimbursement of Expenses as Investment Banker and Financial Advisor to the Official Committee of Unsecured Creditors for the Period January 1, 2019 Through March 31, 2019 [Docket No. 731]; and
- Second Interim Application of Blank Rome LLP, Counsel to the Official Committee of Unsecured Creditors, for Compensation for Services Rendered and Reimbursement of Expenses Incurred for the Period from January 1, 2019 Through March 31, 2019 [Docket No. 732] (together, the “Interim Fee Applications”).

As no responses were received with respect to the Interim Fee Applications, on June 6, 2019, the Committee filed certificates of no objection with the Court explaining that a proposed order on the Interim Fee Applications would follow under separate cover (Docket Nos. 779 & 780).
