CERTIFICATION OF COUNSEL REGARDING *PROPOSED* ORDER INCREASING OCP CAP WITH RESPECT TO LEWIS BRISBOIS BISGAARD & SMITH LLP

On October 29, 2018, the above-captioned debtors and debtors-in-possession (collectively, the "**Debtors**") filed the *Debtors' Motion for an Order Authorizing the Debtors to Retain, Employ, and Compensate Certain Professionals Utilized in the Ordinary Course of Business, Effective as of the Petition Date* [Docket No. 117] (the "**Motion**"). On November 15, 2018, the Court entered an order approving the Motion [Docket No. 231] (the "**OCP Order**").²

The Debtors were recently advised that one of the OCPs, Lewis Brisbois Bisgaard & Smith LLP ("Lewis Brisbois"), has exceeded the OCP Cap (currently \$35,000 per month, on average, over the prior rolling three-month period) by approximately \$4,000, and would likely do so moving forward. In light of this, attached hereto as <u>Exhibit A</u> is a proposed form of order (the "**Proposed Order**") increasing the OCP Cap to \$40,000 per month, on average, over the prior rolling three-month period solely for Lewis Brisbois. The increase would be effective retroactive to October 1, 2019. The Debtors submit that entry of the Proposed Order is appropriate and in

ORDER INCREASING OCP CAP WITH RESPECT TO LEWIS BRISBOIS BISGAARD & SMITH LLP

Upon consideration of the *Certification of Counsel Regarding Proposed Order Increasing OCP Cap with Respect to Lewis Brisbois Bisgaard & Smith LLP* (the "**Certification**");² and it appearing that the relief provided for herein is in the best interest of the Debtors and their estates and creditors; and it appearing that notice of the relief provided for herein is appropriate under the circumstances; and after due deliberation and sufficient cause appearing therefor, it is hereby
