TO BE HELD ON MAY 6, 2020, AT 1:00 P.M. (ET)**

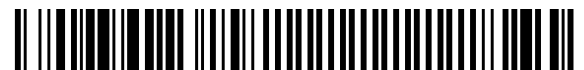
