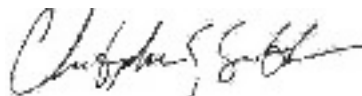
**ORDER APPROVING STIPULATION EXTENDING TIME

**STIPULATION FOR EXTENSION OF TIME FOR
DEFENDANT TO RESPOND TO THE COMPLAINT**
