IT IS HEREBY STIPULATED AND AGREED by and among Earth Pipeline Services, Inc. ("EPS") and Columbia Gas Transmission, LLC ("CGT"), by and through their respective counsel, that the above-captioned consolidated adversary proceedings may be and hereby are dismissed pursuant to Rule 41(a)(1)(A)(ii) of the Federal Rules of Civil Procedure, made applicable to this action by Rule 7041 of the Federal Rules of Bankruptcy Procedure, with each party to bear its own costs, attorneys' fees, and expenses.
