- 2. I respectfully submit this Declaration Requesting Clerk's Entry of Default against the above-named Defendant, US Crossings Unlimited, LLC, (the "<u>Defendant</u>"), for failure to answer or otherwise defend herein.

- 3. ASK LLP was retained by the Plaintiff to avoid and recover preferential payments made to certain creditors in the above-captioned bankruptcy case under 11 U.S.C. §§ 547-550.
- 4. On or about October 20, 2020, the Plaintiff initiated the above-captioned adversary proceeding, Adversary Number 20-50954 (the "Adversary Proceeding"), by filing a complaint to avoid and recover transfers (the "Complaint") against Defendant in the amount of \$2,451,500.00.
