**NOTICE OF ADJOURNMENT OF CERTAIN MATTERS AND
CANCELLATION OF HEARING ON SEPTEMBER 24, 2019 AT 11:00 A.M.**

PLEASE TAKE NOTICE that the hearing scheduled to take place on September 24, 2019, at 11:00 a.m. (Eastern Time) (the “**September Omnibus Hearing**”), before the Honorable Michael E. Wiles, United States Bankruptcy Judge for the Southern District of New York, One Bowling Green, New York, New York 10004 (the “**Bankruptcy Court**”) **has been cancelled.**

¹ On September 25, 2018, many of the Debtors’ Chapter 11 Cases were closed pursuant to the Court’s *Order (I) Consolidating the Administration of Certain Remaining Matters at the Lead Case; (II) Entering a Final Decree Closing Certain Affiliate Cases; and (III) Granting Related Relief* [ECF No. 3956]. The Debtors in the remaining chapter 11 cases, along with the last four digits of each Debtor’s federal tax identification number, if any, are: Westinghouse Electric Company LLC (0933), Stone & Webster Services LLC (5448), WEC Carolina Energy Solutions, Inc. (8735), WEC Carolina Energy Solutions, LLC (2002), WECTEC Global Project Services Inc. (8572), WECTEC LLC (6222), and WECTEC Staffing Services LLC (4135). The Debtors’ principal offices are located at 1000 Westinghouse Drive, Cranberry Township, Pennsylvania 16066.



PLEASE TAKE FURTHER NOTICE that the matters previously scheduled to be heard at the September Omnibus Hearing are hereby adjourned and will be heard at the next omnibus hearing or as soon thereafter as counsel may be heard, including the matters set forth below:

a. The *Omnibus Motion of Debtors Pursuant to 11 U.S.C. §§ 365(a) and 105(a) for Authority to Reject Certain Executory Contracts Related to the VC Summer and Vogtle Projects* [ECF No. 1664], only with respect to the contracts subject to the *Limited Objection of Newport News Industrial Corporation to the Omnibus Motion of Debtors Pursuant to 11 U.S.C. §§ 365(a) and 105(a) for Authority to Reject Certain Executory Contracts Related to the VC Summer and Vogtle Projects* [ECF No. 1725];

b. The *Motion of Transco Products, Inc. for Relief from the Automatic Stay to Permit Setoff of Mutual Obligations* [ECF No. 2426];

c. *Wind Down Co's Sixteenth Omnibus Objection to Claims (No Liability Claims)* [ECF No. 3794], only with respect to proof of claim 2805, regarding which a response was filed by United Association Union [ECF No. 3984], and proof of claim 2773, regarding which a claim was filed by IUPAT Industry Pension Fund [ECF No. 3983];

d. *Wind Down Co's Twenty-Second Omnibus Objection to Claims (Satisfied Claims – Assumed Contracts)* [ECF No. 3810], only with respect to the response filed by Mizuho American Leasing LLC and MHBK (USA) Leasing & Finance LLC [ECF No. 3958];

e. *Wind Down Co's Twenty-Sixth Omnibus Objection to Claims (Satisfied Claims)* [ECF No. 4179], only with respect to proof of claim 3662 filed by CRG Financial LLC (as Assignee of Southern Utility Supply);

f. *Wind Down Co's Twenty-Seventh Omnibus Objection to Claims (No Liability Claims)* [ECF No. 4180], only with respect to proofs of claim 2123, 3441 and 3442 filed by Canon Financial Services, Inc.; and

g. *Wind Down Co's Twenty-Eighth Omnibus Objection to Claims (Reclassify-Reduce and Allow Claims)* [ECF No. 4181], only with respect to (a) the response of Winston & Strawn [ECF No. 4243]; (b) proof of claim 2658 filed by Blanchard Machinery; (c) proof of claim 2122 filed by Canon Financial Services, Inc.; (d) proof of claim 2591 filed by CRG Financial LLC (As Assignee of Pena-Plas Co.); (e) proof of claim 3039 filed by Emerson Process Management, LLP; (f) proof of claim 3048 filed by Emerson Process Management Power & Water Solutions, Inc.; (g) proof of claim 2966 filed by Fisher Controls International, Inc.; and (h) proof of claim 511 filed by Qwest Corporation (d/b/a CenturyLink QC).

h. *Wind Down Co's Thirtieth Omnibus Objection to Claims (No Liability Claims)* [ECF No. 4415], only with respect to proof of claim 3474 filed by the Department of Treasury – Internal Revenue Service Center.

i. *Wind Down Co's Thirty-First Omnibus Objection to Claims (Reclassify-Reduce and Allow Claims)* [ECF No. 4416], only with respect to (a) proof of claim 1883 filed by Hanes Geo Components, and (b) proof of claim 1206 filed by Argo Partners (as transferee of Lakeside Refrigeration).
