**ORDER AUTHORIZING THE
CLOSING OF THE SEGREGATED ACCOUNT,
(II) AUTHORIZING THE REVERSION OF UNCLAIMED
DISTRIBUTIONS, AND (III) GRANTING RELATED RELIEF**

Upon the motion (the “**Motion**”)² of the Debtors for an order (this “**Order**”)
(i) authorizing the closing of Segregated Account and the transfer of remaining Segregated Funds held therein; (ii) authorizing the reversion of all Unclaimed Distributions upon the Unclaimed Distribution Reversion Date (defined below), and (iii) granting related relief, as more fully described in the Motion; and this Court having jurisdiction over this matter therein pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the Southern District of New York*, dated January 31, 2012; and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b); and this Court having found that the Debtors’ notice of the Motion

and opportunity for a hearing on the Motion were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Motion; and this Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Motion is granted as set forth herein.
2. Wind Down Co and the UCC are authorized and directed to close the Segregated Account upon the occurrence of the Unclaimed Distribution Reversion Date and transfer all remaining Segregated Funds held in the Segregated Account at such time (such amount, the “**Remaining Segregated Funds**”) pursuant to the terms of this Order.
3. Upon the closing of the Segregated Account, Wind Down Co and the UCC are authorized and directed to transfer the Remaining Segregated Funds as follows: (i) \$3,784,783.60 to an account maintained by Wind Down Co for the express purpose of maintaining a disputed claims reserve on account of Claim No. 3474 filed by the Internal Revenue Service (the “**IRS Claim**” and such reserve, the “**IRS Claim Reserve**”), (ii) 95% of the Remaining Excess Funds (after first establishing the IRS Claim Reserve) to Wind Down Co or the Consenting Claimholder, as the sole holder of Allowed Class 3B General Unsecured Claims, and (ii) 5% of the Remaining Excess Funds (after first establishing the IRS Claim Reserve) to Reorganized WEC, to be contributed by Reorganized WEC to its pension plans in accordance with the Pension Funding Agreement.
4. Following the resolution of the IRS Claim, Wind Down Co shall transfer 5% of any funds remaining in the IRS Claim Reserve to Reorganized WEC, to be contributed by Reorganized WEC to its pension plans in accordance with the Pension Funding Agreement.

5. In addition to the IRS Claim, Wind Down Co will continue to maintain a separate \$8,701,581.94 reserve on account of Toshiba's Disputed Administrative Expense Claim, and shall maintain such dedicated reserve pending the resolution of Toshiba's claim, whether such claim were Allowed, if at all, as a Class 3A General Unsecured Claim or an Administrative Expense Claim.

6. Any Unclaimed Distributions on account of Allowed Class 3A General Unsecured Claims remaining on the Unclaimed Distribution List as of the Unclaimed Distribution Reversion Date (such amounts, the "**Unclaimed Class 3A Amounts**") shall automatically and irrevocably revert to the Segregated Account on the Unclaimed Distribution Reversion Date, and the Distribution Agent is authorized and directed to transfer all Unclaimed Class 3A Amounts to the Segregated Account. All Unclaimed Class 3A Amounts shall be included in the calculation of Remaining Segregated Funds.

7. Any Unclaimed Distributions on account of Allowed Claims (other than Allowed Class 3A General Unsecured Claims) remaining on the Unclaimed Distribution List as of the Unclaimed Distribution Reversion Date (such amounts, the "**Unclaimed Non-Class 3A Amounts**") shall automatically and irrevocably revert to Wind Down Co on the Unclaimed Distribution Reversion Date, and the Distribution Agent is authorized and directed to transfer all Unclaimed Non-Class 3A Amounts to Wind Down Co.

8. A list of Unclaimed Distributions is attached hereto as **Exhibit 1**.

9. On and after the Unclaimed Distribution Reversion Date, Wind Down Co shall not be required to make any Distributions on account of the Unclaimed Distributions and the Claims underlying such Underlying Distribution shall be deemed released, settled, compromised, and forever barred.

10. Wind Down Co, the Plan Oversight Board, the UCC, the Distribution Agent, and Citibank, N.A. are authorized to take all actions necessary or appropriate to give effect to this Order.

11. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.
